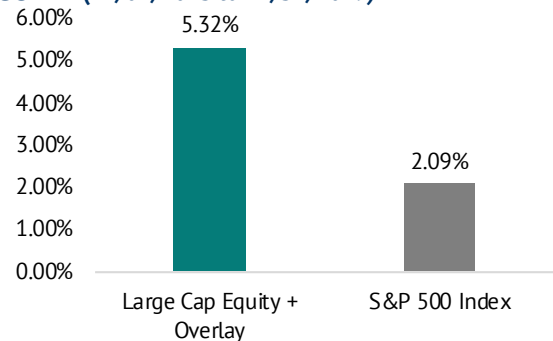

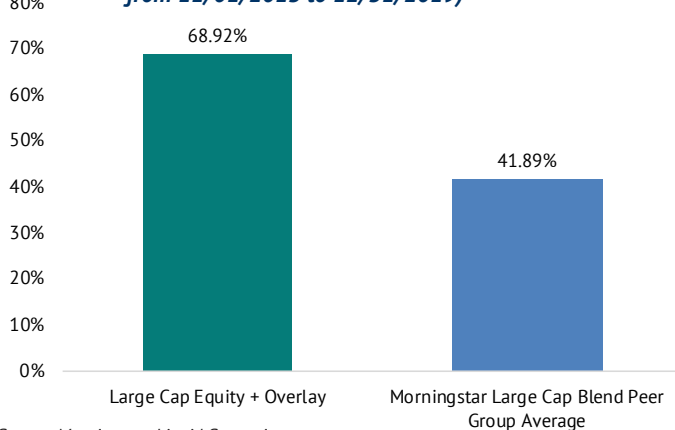

ILLUSTRATIVE ANNUALIZED DISTRIBUTED INCOME (11/01/2013 to 12/31/2019)



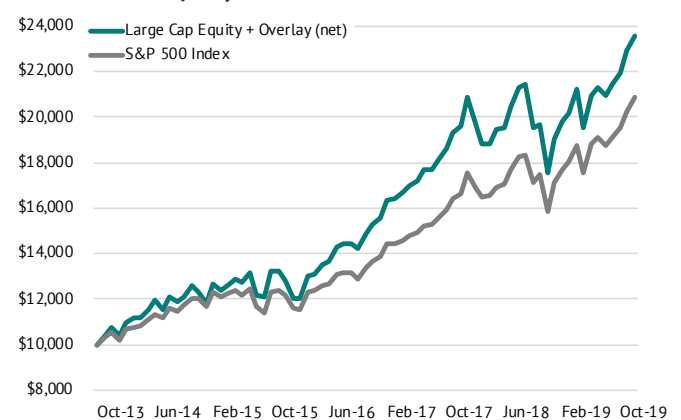

S&P 500 Index (SPX) - The S&P 500 Index is an unmanaged index commonly used as a benchmark to measure the performance and characteristics of U.S. large cap stocks. Sharpe Ratio - A measure for calculating risk-adjusted return. The Sharpe ratio is the average return earned in excess of the risk-free rate per unit of volatility or total risk. Subtracting the risk-free rate from the mean return, the performance associated with risk-taking activities can be isolated. Sharpe ratio = (Mean portfolio return - Risk-free rate)/Standard deviation of portfolio return. For Sharpe Ratio calculations in this presentation, the "risk free rate" is represented by the annualized monthly returns of the 3 Month US T-Bill.

Annualized Distributed Income - Represents annualized estimated distributions of the actual income generated by the Liquid Strategies Overlay and the actual income distributed from the underlying security (Vanguard S&P 500 ETF) since the inception of the Overlay strategy (11/1/2013).
